UN Countering Terrorist Travel Programme

Highlights

for Law Enforcement Agencies in Nigeria, 8-11 May: (IWG), 17 May: CT Travel and the Airport IOM and UNOCT, in collaboration with the U.S. Department of State's Bureau of Counterterrorism, conducted a four-day workshop in Abuja to enhance the capacity of the Federal Government of Nigeria in border security and strengthen their counter-terrorism efforts across the country.



Memorandum of Understanding (MoU) with Hungary, 13 June: UNOCT and the Government of Hungary, signed an MoU to formalize their partnership in preventing and countering terrorist travel and serious crimes under the United Nations Countering Terrorist Travel Programme.



IOM and UNOCT hold Border Governance Workshop Western Africa Regional Informal Working Group Communication Programme (AIRCOP) implemented by **UNODC**, organized the second annual regional IWG meeting for over 70 delegates representing law enforcement, counter-terrorism, security, and civil aviation agencies from 16 West African countries and four observer States.



CT Travel Programme Donors Forum: Highlighting Achievements, Impact, and Lessons Learned, 19 June: UNOCT, together with the CT Travel Programme partners, organized a hybrid side event, 'Donors Forum on the margins of the Third Counter-Terrorism Week (CT Week) in New York.



Regional Workshop for the Middle East and North Africa (MENA), 29-31 May: More than 100 participants from 13 Member States in the MENA, attended a regional workshop in Cairo on "Setting-Up A Passenger Information Unit and Processing API and PNR." The workshop was jointly organized by UNOCT and UNODC under the framework of the CT Travel Programme, and hosted by the Government of Egypt.



Memorandum of Understanding (MoU) with Diibouti, 23 June: UNOCT and the Government of Djibouti signed an MoU to formalize their partnership in preventing and countering terrorist travel and serious crimes under the United Nations Countering Terrorist Travel Programme.



Member State Implementation (16 'active Member States'1*)

Operational: AIRCOP held six operational working group meetings and six working meetings specializing drafting of Standard Operating Procedures/Terms of Reference for the Passenger Information Units (PIUs) of six Member States. They also undertook two study visits, one to the Luxembourg PIU for Botswana (in-person/hybrid) and the other to the Belgium PIU for Togo (in-person).

Legal: The Mongolia Passenger Data Regulations (API/PNR) were adopted, bringing to three the number of legal texts adopted with CT Travel support. During Q2, the Terrorism Prevention Branch (TPB) held 27 legal working groups or engagements. Additionally, TPB circulated the first draft of the recommended legal provisions on maritime traveler data.

Transport Industry: ICAO held eight working group meetings with seven different beneficiary countries as well as five connectivity meetings.

Technical: Four Member States entered preproduction, bringing the total to two in production with goTravel Software Solution; eight in preproduction; and four close to pre-production. In terms of activity, OICT held 15 working group meetings focusing on goTravel deployment or installation, and 30 software maintenance support-related meetings.

INTERPOL: Participated in or led three technical integration meetings for Botswana, Israel, and Norway, and attended two Programme-related trainings or conferences.

IOM: Held 26 meetings or activities related to the coordination, and implementation of the CT Travel Programme, including two dedicated Programme Management Team (PMT) meetings in coordination with IOM field operations. CT Travel participated in the IOM Immigration and Border Governance Retreat.































About CT Travel

The objective of the UN CT Travel Programme is to build Member States' capabilities to prevent, detect and investigate terrorist offenses and other serious crimes, including related travel, by:

- Collecting and analyzing travel information such as passenger data, namely Advance Passenger Information (API) and Passenger Name Record (PNR);
- Improving the use of international databases with known and suspected terrorists and criminals, such as the databases of the International Criminal Police Organization (INTERPOL); and
- Enhancing international information exchange, in line with UN Security Council resolutions 2178, 2396, and 2482.

The detection capabilities, that the Programme helps establish, commonly referred to as Passenger Information Units (PIUs), are in charge of processing passenger data provided by the transport industry using the <u>UN 'goTravel' software</u> solution, based on solid legislation and regulations established with the Programme's assistance.

Executive Summary | Key Successes in Numbers

Throughout Q2, UNOCT led 58 All-of-UN activities in collaboration with one or more partners, with a view to ensure coordination across the pillars of the CT Travel Programme. 15 communication products, seven press releases or web stories and eight tweets, were published. 241 actions and activities were registered in the "CT Travel Activity Tracker" for Q2 across all partners.



April: UNOCT USG, Mr. Voronkov, met with ICAO SG, Mr. Salazar, to discuss the eighth review of the United Nations Global Counter-Terrorism Strategy, the Third United Nations Counter-Terrorism Week, CT Travel, and the TAM Programme, to detect and counter terrorist travel and threats to aviation security.

May: One National Consultation for Malawi on API and PNR, held in Lilongwe on 3-4 May, a Border Governance Workshop, held in Abuja on 13 May, a Regional Informal Working Group on API and PNR held in Côte d'Ivoire, on 16-17 May, and a Regional Workshop for the Middle East and North Africa held in Egypt on 29-31 May.

June: An Memorandum of Understanding (MoU) with Hungary was signed on 13 June, a Privacy and Data Protection Workshop held in the Budapest Regional Programme Support Office (RPSO) on 13-14 June, the CT Travel Programme Donors Forum: Highlighting Achievements, Impact, and Lessons Learned, that took place on 19 June, and an MoU with Djibouti signed on 23

Training Approach

CT Travel Programme has a variety of training courses available for Member States:

- CT Travel foundational course covering four eLearning modules on the basics of API and PNR, the international legal framework, establishment of a PIU and a Passenger Data Single Window, and Hit and Match, delivered self-paced online;
- An Interactive <u>CT Travel Training course</u> delivered in-person or hybrid over four-five days and covering all key aspects of the Programme;
- A Specialised Rules Based-Targeting Training designed for operators and analysts in the Passenger Information Unit;
- A goTravel-user basic training designed to apply the RBT training in the goTravel system; and
- A Technical IT training on the deployment and installation of goTravel.

CT Travel Training Delivery: One Rules-Based Targeting training took place for Mongolia in April, and one joint training for Nigeria was held in May. In addition, one Privacy and Data Protection Workshop was held in June at the UNOCT Regional Programme Support Office in Hungary, with the presence of 20plus experts from eight different countries.

CT Travel Training Development: Development of new eLearning and microlearning modules, on (i) Maritime, (ii) Human Rights, and (iii) goTravel is ongoing.
