## Bios of panelists and chairs

## Yilmaz Akyuz

Yilmaz Akyuz is currently the Special Economic Advisor to South Centre, a Genevabased Intergovernmental Think Tank of the Developing Countries. Prior to this position, he served as the Director of the Division on Globalization and Development Strategies at the United Nations Conference on Trade and Development (UNCTAD). Here he was the principal author and head of the team preparing the Trade and Development Report, and UNCTAD coordinator of research support to developing countries (the Group-of-24) in the IMF and the World Bank on International Monetary and Financial Issues. He taught at various universities in Turkey and Europe and has published extensively on macroeconomics, finance, trade, growth and development. He is the second holder of the Tun Ismail Ali International Chair in Monetary and Financial Economics at the University of Malaya, established by Bank Negara.

## Diana Alarcón

Diana Alarcón is currently Senior Economic Affairs Officer in the Development Policy and Analysis Division at UN DESA. In different capacities, she has been working on the MDG agenda since 2002 and has been part of the UN System Task Team to support the analytical work around the post-2015 development agenda. She has done research and contributed to the development of programs for employment creation, poverty reduction and social protection. Ms. Alarcon has a PhD in Economics from the University of California and has taught in various universities in Mexico and the United States.

## Nagapudi Bhanumurthy

Dr. N R Bhanumurthy is currently working as Professor at the National Institute of Public Finance and Policy, New Delhi. Prior to this he worked as Assistant/Associate Professor at the Institute of Economic Growth, Delhi for nearly nine years. He received his Masters and M.Phil from the University of Hyderabad, Hyderabad and his Ph.d on international finance from the Institute for Social and Economic Change, Bangalore. He has worked for UNESCAP, Bangkok and also as macroeconomist for the UNDP Regional Centre for the Asia-Pacific region at Colombo. Currently he is the Secretary of the Indian Econometric Society and also Managing Trustee of Indian Economic Association Trust for Research and Development. At present, he is also serving on committees of Planning Commission, Ministry of Finance, Ministry of Statistics, FICCI and CII.

#### David Le Blanc

David Le Blanc is an economist. He is currently working in the Division for Sustainable Development in the United Nations Secretariat in New York. While at the UN, he has worked on financing, integrated scenarios and strategies for sustainable development, mining, water and electricity subsidies and sustainable development assessments. Prior to joining the United Nations, David worked at the World Bank as Senior Economist in the Urban and Housing Finance groups, focusing on projects and technical assistance on housing policy, housing subsidies, and housing finance. Earlier in his career, David worked at the French Statistical Institute (INSEE) as official statistician and CREST, Paris as a research fellow. David holds diplomas from Ecole Polytechnique, Paris, Ecole Nationale de la Statistique et de l'Administration Economique, Paris, and a Diplôme d'Etudes Approfondies in Stochastic Modeling Applied to Finance from Paris VII University.

#### Roehlano M. Briones

Roehlano M. Briones is a Senior Research Fellow at the Philippine Institute for Development studies. He is the lead expert in the application of MAMS to the Philippines. His other research interests are agricultural policy, rural and agricultural development, and resource economics. #### Gustavo Canavire Bacarezza

## Anisuzzaman Chowdhury

Prior to this he served as Senior Economic Affairs Officer in the Office of the Under Secretary General at UN DESA. Mr. Chowdhury has been a consultant to UNDP, ILO, the Commonwealth Secretariat, and the Islamic Development Bank and has been a visiting fellow at UNU-WIDER, the Reserve Bank of San Francisco and the Institute of Southeast Asian Studies (Singapore).

## Stephany Griffith Jones

Stephany Griffith Jones specializes in international finance and development with emphasis on the reform of the international financial system, specifically in relation to financial regulation, global governance and international capital flows. Currently she is Financial Markets Director at the Initiative for Policy Dialogue, based at Columbia University in New York and Associate Fellow at the Overseas Development Institute. Previously she was Professorial Fellow at the Institute of Development Studies at Sussex University. She has also held the position of Deputy Director of International Finance at the Commonwealth Secretariat and has worked at the United Nations Department of Economic and Social Affairs and in the United Nations Economic Commission for Latin America and the Caribbean.

# Elliot Harris

Elliot Harris joined UNEP as Director of the New York Office and of the Secretariat of the Environment Management Group in September 2013. Prior to this, he worked as an economist in the IMF from 1988 to 2013, gaining extensive policy and programmatic experience in African and Central Asian countries, as well as in the Fiscal Affairs Department on public expenditure policy issues. From July 2002 onward, Mr. Harris served as Advisor and Assistant Director in the IMF's Strategy, Policy and Review Department, including as Chief of the Development Issues Division. From September 2008 until May 2012, he was also the IMF's Special Representative to the United Nations. From September 2009 until October 2013, he was the Vice Chair of the High-Level Committee on Programs of the UN Chief Executives Board for Coordination.

# Pingfan Hong

Pingfan Hong is Acting Director of the Development Policy Analysis Division (DPAD) of UN DESA. Prior to this position he served as Chief of the Global Economic Monitoring Unit of DPAD. He joined the United Nations in 1998 and has also worked as an officer in the State Planning Commission of China and as a Research Fellow and Assistant to Professor Lawrence Klein at the University of Pennsylvania. He is the key developer of MAMS (Maquette for MDG [Millennium Development Goal] Simulations), a model for medium- to long-run country-level policy analysis that has been applied to some 50 countries with a focus on fiscal policy, MDGs, education, and the labor market, including collaborative projects between the World Bank, UN DESA, and researchers and governments in developing countries. He joined the World Bank in June 2004. Prior to this he was a Senior Research Fellow at the International Food Policy Research Institute (IFPRI). Mr. Lofgren holds a Ph.D. in Economics from the University of Texas at Austin.

# Marvin Miranda
