3.15 – 4.25 pm **Panel 1: On the occasion of the 40th Anniversary of the Additional Protocols to the Geneva Conventions – the impact and importance of International Humanitarian Law**

The aim of the first panel is to address the impact of the Additional Protocols on the parties to armed conflicts, on states, non-state actors and humanitarian actors. Possible issues for discussion include what the AP:s have taught us in terms of experiences of implementation regarding for example protection medical persons, conduct of hostilities, fundamental guarantees and detainees as well as sexual and gender based violence and humanitarian access.

Peaceful settlement of disputes is evidently an important contribution to preventing conflicts. In addition, several other aspects may be addressed during the panel, such as the significance of international law in mediation, arbitration, international law and justice as a roadmap towards peace (during conflict) and international law and justice as tools for lasting peace (post-conflict).
