#### Introduction

1. On 25 March 2022, the Applicant, a former Regional Technical Advisor, Bureau for Policy and Programme Support ("BPPS"), United Nations Development Programme ("UNDP"), Regional Hub, Istanbul, received the disciplinary sanction of separation from service with compensation in lieu of notice and without

termination indemnity.

2. On 21 June 2022, the Applicant filed the instant application.

3. On 22 July 2022, the Respondent filed his reply.

4. By notification dated 7 June 2023, the Tribunal invited the parties to attend a

Case Management Discussion ("CMD") on 14 June 2023, and instructed the

Applicant to file his rejoinder, if any, by 14 June 2023 at noon Geneva time.

5. On 8 June 2023, the Applicant requested an extension of time to file his

rejoinder until 21 June 2023, which was granted by notification on the following

day.

6. On 14 June 2023, the parties attended a CMD, held virtually via

Microsoft Teams.

7. On 21 June 2023, the Applicant filed his rejoinder.

Consideration

Hearing on the merits

8. At the CMD, the Applicant manifested his desire to have a hearing on the

merits, which the Respondent opposed.

9. In its rejoinder, the Applicant reinforced the request for a hearing on the

merits, particularly to hear his testimony and that of the following witnesses, who

are allegedly able to provide some information concerning the Applicant's alleged

involvement in unauthorized outside activities:

- a. Mr. Marcel Alers, former UNDP Head of Energy and First Reporting Officer ("FRO") of the Applicant;

- 10. Having considered the parties' positions, the Tribunal is of the view that a hearing on the merits is warranted in this case, specifically to clarify the issues surrounding the Applicant's alleged involvement in unauthorized outside activities.
