Introduction

1. On 28 July 2022, the Applicant, a Movement Control Officer with the United

Nations Organization Stabilization Mission in the Democratic Republic of the Congo,

("MONUSCO"), Goma, filed an application contesting the decision to remove her

from the position of Chief of Joint Movement Coordination Centre ("JMCC") and to

reassign her as Bonded Warehouse Supervisor.

2. The Tribunal issued Order No. 037 (NBI/2023) on 14 February 2023, on case

management, in which potential witnesses were identified by the Tribunal and the

parties were given directions with a view to preparing for an oral hearing of this matter.

Consideration

3. In compliance with the directions of the above-mentioned order, the parties

communicated to the Registry (the Respondent by email of 22 February, and the

Applicant by email of 20 February 2023) their availability for the hearing, asking to set

it only in the period 27 March to 3 April 2023 and confirmed the availability of the

witnesses to attend the hearing.

4. The Respondent opted not to call Mr. Bakou Amankou Philippe; he proposed

to call in addition the Chief Human Resources Officer for MONUSCO, Mr. Ebow Idun.

Apart from that, the parties did not ask for additional evidence.

5. The Tribunal notes that all parties, witnesses and counsels are in the same

continent and that there are no relevant zones' time differences that can impact to the

scheduling of the hearing.

6. **NOTICE** is hereby issued that the matter of *Guimares v. Secretary General of*

the United Nations (UNDT/NBI/2022/064) is set down for oral hearing in the UNDT

Courtroom in Nairobi, from 27 March 2023 to 3 April 2023.
