Introduction

1. On 1 November 2023, a Case Management Discussion ("CMD") was held with the participation of the Applicant and Counsel for both parties, as per Order No. 113 (NY/2023) of 23 October 2023.

- 2. At the CMD, the parties agreed that the main issues for consideration in this case are:
 - (a) Whether the application is not receivable *ratione materiae* because the Applicant failed to submit a timely request for management evaluation after notification of the impugned decision;
 - (b) Whether the Applicant was given priority consideration for placement after the abolition of his post leading to termination of his permanent appointment;
 - (c) Whether UNICEF met its obligations to assist the Applicant in identifying available suitable posts in which his services could be utilized; and
 - (d) Whether the Applicant was subjected to a competitive selection process for available suitable posts.
- 3. The parties agreed that the application could be decided on the papers subject to an oral motion for disclosure of documents in the possession of the Respondent.
- 4. In light of the discussions at the CMD,

IT IS ORDERED THAT:

- 5. Pursuant to arts. 16.1 and 19 of the UNDT Rules of Procedure, providing for oral hearings and case management respectively, and for a fair and expeditious disposal of the case, the application shall be decided on the papers only as an oral hearing is not necessary.
- 6. The Applicant's oral motion for disclosure is granted on the following terms:

By 3:00 p.m. on Friday, 10 November 2023, the Respondent shall file documentation covering the period from 1 July 2019 to 30 September 2022, specifically:

(a) Communications between the UNICEF Human Resources Office and Hiring Managers regarding priority consideration for the Applicant who was facing termination; and

(b) Communications regarding the Applicant's participation in the Senior Staff Rotation and Reassignment Exercise ("SSRRE").

7. **By 3:00 p.m. on Friday, 1 December 2023**, the parties shall file their respective closing submissions, which shall include any relevant observations on the documentation filed under Order No. 061 (NY/2023) and para. 6 above. The submissions shall not exceed seven pages, using font Times New Roman, font size 12 and 1.5 line spacing.
