Terms of Use for use of the messaging platform in support of the UN Act Now Climate Action Campaign

Please read these Terms of Use which include a Privacy Statement and General Terms and Conditions that apply to your interaction with the UN Act Now Climate Action Campaign through the WhatsApp messaging platform. By messaging the UN Act Now Climate Action Campaign using WhatsApp, you are confirming that you understand and agree to these terms.

Privacy Statement

When you interact with the UN Act Now Climate Action Campaign, you accept to provide to the United Nations the personal information needed to reply to your messages. You can, however, stop interacting with the UN Act Now Climate Action Campaign and request the deletion of your data as explained below.

1. What data is collected and with whom is it shared?

Your data is collected by the United Nations and shared with our technology partner, Praekelt PBC(Praekelt) and with WhatsApp. The data gathered, stored and shared is as follows:

As the WhatsApp messaging platform is used for the service, WhatsApp will also capture certain data unrelated to the UN Act Now Climate Action Campaign, as per the WhatsApp Terms of Service.

2. Why is the United Nations collecting your data?

The United Nations will use the data collected for the purpose of the UN Act Now Climate Action Campaign.

Praekelt will have access to and process the same data in order to support the UN Act Now Climate Action Campaign through the WhatsApp platform, routing messages from users to the United Nations and back, and facilitating the automation of message delivery based on the content of messages received.

In addition, the United Nations and Praekelt will collect anonymized data about participation in the UN Act Now Climate Action Campaign, which will be utilised to review and improve engagement with civil society on climate and other issues within the mandate of the United Nations. The United Nations will not sell your data, and will not disclose it other than as disclosed in this Privacy Statement. Praekelt has also committed to use your data only for the limited purposes described here.

3. How to opt out or request deletion of your data?

You can choose to stop engaging with the UN Act Now Climate Action Campaign at any time and ask for your data to be deleted. Simply message the phrase "STOP" to no longer receive messages. To request deletion of your data and interactions, simply message the word "ERASE" and you will be prompted to confirm you no longer wish to receive messages from the UN Act Now Climate Action Campaign and wish to delete your data stored by the United Nations, including all messages exchanged with the United Nations.

Your data will be stored by the United Nations for a maximum period of 365 days since your last engagement with the UN Act Now Climate Action Campaign, after which it will be deleted; except for the anonymized data used by the United Nations and Praekelt. for assessment of the UN Act Now Climate Action Campaign.
