CONSULTANT

Jayati Ghosh (India) is a an economist and professor whose many interests include globalization, international finance, employment patterns in developing countries, macroeconomic policy, and issues related to gender and development. She is one of the world's leading female economists. She is professor of Economics at Jawaharlal Nehru University, New Delhi, and the executive secretary of International Development Economics Associates (IDEAS). International Development Economics Associates is a network of heterodox economists critical of the mainstream economic paradigms. Professor Ghosh has been a consultant and researcher for many government and non-government organizations, nationally and internationally. She was a member of the National Knowledge Commission set up by the Indian Prime Minister. Recent books include "Never done and poorly paid: Women's work in globalising India" (New Delhi: Women Unlimited 2008) and "After Crisis: Adjustment, recovery and fragility in East Asia" (New Delhi: Tulika 2009). She has also worked closely with many progressive organizations and social movements.

EXPERTS

Susana Lastarria-Cornhiel (Peru) has worked on international development issues throughout her career. Her current research focuses on gender and land rights, particularly the impact of land rights on women's status, economic opportunities, and well being. Prior to joining the Urban and Regional Planning Department at the University of Wisconsin, Dr. Lastarria-Cornhiel worked as senior researcher at the Land Tenure Center, the leading university-based research institution on land policy in the world. Her recent publications include: The Women of Isoso: Livelihoods, Governance and Natural Resources in the Gran Chaco, Bolivia (2008), Feminization of Agriculture: Trends and Driving Forces (2006), and Shared Tenure Options for Women: A Global Overview (2005).

Verena Schmidt (Germany) is a Senior Specialist, Conditions of Work and Employment/Gender Equality at the ILO Subregional Office for Central and Eastern Europe. Prior to this assignment, she worked in the ILO Bureau for Workers' Activities (ACTRAV). She founded and coordinated the Global Union Research Network and was involved in curriculum development in the Global Labour University. She was the alternate gender coordinator where she carried out two gender audits with the Russian trade union federation and Education International, a global union federation. She was also focal point for multinational enterprises and Corporate Social Responsibility within ACTRAV. She recently published a book on "Trade Union Responses to Globalization" and was the editor of the newly founded "International Journal of Labour Research".

Elaine Unterhalter (South Africa) is Professor of Education and International Development at the Institute of Education, University of London. She has more than 25 years experience working on themes concerned with gender, race and class inequalities and their bearing on education. Her current research projects include "Gender, education and global poverty reduction" with the Economic and Social Research Council, "Transforming education for girls in Nigeria and Tanzania" and "Stop Violence against girls" with ActionAid, and "Education and the capability approach Beyond access: gender, education and development" with the Commonwealth Education Fund.

Eva Rathgeber (Canada) is a consultant in international development. From 2002-2006 she held the Joint Chair of Women's Studies at the University of Ottawa/ Carleton University in Ottawa, Canada. She spent many years with the International Development Research Centre (IDRC). Dr Rathgeber established and led IDRC's first gender and development program and has worked closely with gender researchers throughout Africa for many years. Her areas of expertise include: gender and poverty analysis, national resource management, social analysis of information, communication technology and social policy analysis in international development.

Piroska Östlin (Sweden) is Associate Professor in Public Health at the Karolinska Institutet in Sweden with a Ph.D. in Medical Science from the University of Uppsala. During the last ten years, she has been working extensively for the World Health Organization (WHO) as an adviser on gender and health equity issues. Östlin was coordinator of two WHO task forces (in 2004 and 2009) on Research Priorities for Equity in Health. Since 2009, Östlin is Member of the WHO Scientific Group on Equity Analysis and Research. Together with Gita Sen, Östlin was coordinator of the Women and Gender Equity Knowledge Network of the WHO Commission on Social Determinants of Health (CSDH). She is Member of Board of the European Institute of Women's Health. Her former positions include Secretary of the Swedish Public Health Commission, Expert in International and Global Health at the Swedish National Institute of Public Health and Member of Board of the Nordic School of Public Health. Her publications include Gender Inequalities in Health: A Swedish Perspective, Harvard University Press, 2001 (with Danielsson M, Diderichsen, et al), Engendering International Health: The Challenge of Equity, MIT Press, 2002 (with Sen G and George A) and "Gender Equity in Health: The Shifting Frontiers of Evidence and Action" (with Sen G), Routledge, 2010.

Tomris Türmen (Turkey) has served for 15 years in WHO as an Executive Director responsible for gender, women's, children's and adolescent's health as well as reproductive health and rights including HIV/AIDS. She has led WHO's conceptual work leading to position papers for Cairo, Beijing and MDGs. Previously, she was the Director General of Maternal and Child Health and Family Planning and served as Deputy Permanent Secretary in the Ministry of Health of Turkey. She is currently professor of pediatrics and heading the Department of Pediatrics / Newborn Medicine in the University of Ankara, Turkey and is the President of International Children's Center, a nongovernmental organization whose work focuses on human rights, including child and women's rights.

Rachel Napinga (Uganda) is an Environment and Community activist. She is the Director of Programmes for Eco-Watch Africa, based in Kampala, which ensures gender equality in sound environmental management and is the coordinator of the Gender and Climate Change network in Africa. In 2006 she was President of the Africa Youth Initiative on Climate Change. From 2004-2007 she has participated in the UN meetings on climate change (COP) as part of the global and climate change network. She has been involved in a number of consultancies, including a consultative report on recommendations on gender and energy at the Africa Partnership Forum to the G8 at the Civil G8 Summit.

Agnes Kabajuni (Uganda) is the Women and Housing Rights Programme Officer for Africa of the Centre on Housing Rights and Evictions (COHRE) She has undertaken reasearch on issues such as urbanisation, HIV/AIDS, and women's housing, land and inheritance rights in Africa. She was recipient of the The Ford Foundation International Fellowships In East Africa. Ms. Kabjuni has participated in a number of international meetings, including organized by UN-Habitat.

Jyoti Parikh (India) serves as Executive Director of Integrated Research and Action for Development (IRADe). She was a Senior Professor at Indira Gandhi Institute of Development Research (IGIDR). She is a Member of the Prime Ministers's Council on Climate Change India and is a recipient of Nobel Peace Prize awarded to IPCC authors in 2007. She also worked at the International Institute for Applied Systems Analysis (IIASA) for eight years. She worked for nearly thirty years on energy and environment problems of the developing countries. She has served as energy consultant to the World Bank, the U.S. Department of Energy, European Economic Community, Brussels and UN agencies such as UNIDO, FAO, UNU, and UNESCO, Environment Consultant to UNDP, World Bank and so on. She has worked on gender budgeting, gender and environment, gender and energy for UNDP, the World Bank and for national government and international organizations and carried out various research and policy studies on gender, environmental sustainability, poverty alleviation and climate change. She leads the National Focal for India for the International Network for Gender and Sustainable Energy (ENERGIA).

Marzia Fontana (Italy) is a development economist with over 15 years of research and teaching experience in the area of gender, labour markets, unpaid work and international trade. She is currently a Research Fellow at the Institute of Development Studies (Participation, Power and Social Change Team) and Director of its MA Gender and Development programme. She has previously worked at the Economics Department of the University of Sussex, at the International Food Policy Research Institute in Washington D.C. and at the Reserve Bank of Fiji. She has written extensively on the gender effects of trade policies, including a contribution to the book *The Feminist Economics of Trade* (edited by van Staveren et al.).
